Tuition Rates for 2010-2011

The following tuition rates for the 2010-2011 school year were approved at a recent meeting of the Board of Pastors. A yearly increase in tuition is necessary in order to meet the increase in expenses.

Tuition vs. Actual Per Pupil Cost

It is important to note that the tuition rates listed above do not reflect the actual amount it costs to educate a child at Hoboken Catholic Academy. **Actual cost per pupil for the 2010-2011 school year is projected to be over \$6,500,** while the highest tuition rate for a student in Kindergarten through Grade 8 is only \$4,630. Income from tuition and registration covers less than 70% of the school's expenses. We rely on fundraising, donations and other income to cover the gap between tuition income and normal operating expenses. It is expected that each family will make every effort to support the fundraisers that are held throughout the year, or contribute in whatever way they can to reduce the gap between income and expenses.

Payment of Tuition

Tuition payments are made through Smart Tuition Management. The first payment is due July 10th. Failure to make tuition payments on time will result in the suspension of educational services for your child.

The following tuition payment plans are available:

- 1 month: Full tuition paid in one payment – 5% discount if paid by July 2010
- 2 months: Tuition paid in two payments- July & November
- 4 months: Tuition paid in four payments-July, October, January, & March
- 10 months: Tuition paid in ten payments-Monthly July through April

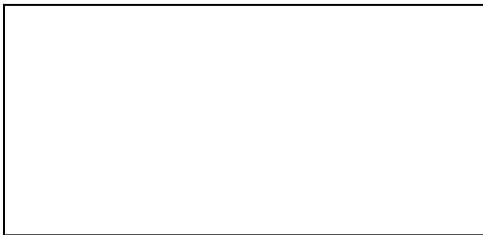
